**RESOLUTION**  
**Section 15-00130-01-BR**

**WHEREAS**, Sangamon County is desirous of performing an emergency design/repair of a bridge on Cardinal Hill Road (CH 37) 1.5 mile north of New City; and,

**WHEREAS**, the outside two western most beams on the north two spans have separated and a review by the IDOT bridge office indicates that the keyway connectors have failed and are in need of repair; and,

**WHEREAS**, barricades have been placed along the west side of the bridge to keep traffic off of the beams and a signs for a weight limit posting of "legal load only" have been erected; and,

**WHEREAS**, Cardinal Hill Road is a major north/south route in eastern Sangamon County that carries agriculture and other commodities and equipment that require the full width and structural capacity of the bridge to be in effect; and,

**WHEREAS**, a quote of \$53,502.77 to perform an emergency design/build emergency repair of the failed keyways, repair the expansion joint and to install retainer clips to keep the beams from further movement along with the necessary traffic control and preparation of detailed repair plans signed by a registered structural engineer was obtained from Sangamo Construction Co., Springfield, IL; and,

**NOW THEREFORE BE IT RESOLVED**, by the County Board of Sangamon County, at its **Regular Reconvened Adjourned September Session**, assembled this 6<sup>th</sup> day of October, A.D., 2015 that the emergency repair design/build contract with Sangamo Construction Co., Springfield, IL for a bridge repair on Cardinal Hill Road (CH 37) 1.5 mile north of New City is approved; and,

**BE IT FURTHER RESOLVED** that the emergency repair design/build contract with Sangamo Construction Co., Springfield, IL with a cost not to exceed \$55,000.00 is hereby approved and the Chairman of the County Board is directed to sign said contract.




