WHEREAS, the County has identified the need to purchase 100 replacement radios during the Fiscal Year beginning December 1, 2018; and

WHEREAS, all current radios are 10 years or older, annual repair costs are increasing, and the current radios will no longer be supported at the end of 2019; and

WHEREAS, Motorola and Wireless USA were awarded the State of Illinois contract for radios; and

WHEREAS, financing will be entered into a contract with Motorola at 0.00%, and

WHEREAS, the financing shall be a three year contractual agreement that will be filed with the Auditor's Office, and

WHEREAS, for the one hundred (100) radios being financed, at a total cost of two hundred fifty eight thousand five hundred fourteen (\$258,514) will be borrowed; the County will pay regular annual payments of \$86,171.34 as of each payment date, April 1, 2020, April 1, 2021, and April 1, 2022 respectively; and

NOW THEREFORE BE IT RESOLVED BY THE COUNTY BOARD MEMBERS OF SANGAMON COUNTY, in session this 8th day of April, 2019 A.D., that the above purchases are accepted for the radios at the cost listed above, for payment of said radios from Long Range Planning appropriation.

## Purchase Order Narrative for Patrol and Court Security Radios

### Summary:

The Sangamon County Sheriff's Office has the need to replace 100 radios for Patrol and Court Security. All current radios are 10 years or older, annual repair costs are increasing and the current radios will no longer be supported at the end of 2019.

Motorola Solutions and Wireless USA were awarded the radio contract with the State of Illinois and therefore an RFP nor quotes are required via the procurement process. The contract represents a 27% discount from the list price.

This equipment was identified in FY19 budget forecasting. In working with Motorola Solutions, equal payments of \$86,171.34 will be made in FY20, FY21, and FY22, however the Sheriff's Office will receive this equipment now.

The PO amount reflects the actual total cost.
