WHEREAS, the County Board of Sangamon County approved an Engineering Agreement with IE Consultants, Inc. on April 12, 2000 to prepare plans to improve County Highway 17 (Bradfordton Road) from West Washington Street to County Highway 8 (Old Jacksonville Road) a distance of approximately one mile; and,

WHEREAS, additional services are needed to complete the environmental and plan documents; and,

WHEREAS, IE Consultants, Inc., was recently purchased by Quigg Engineering, Inc.; and,

WHEREAS, Quigg Engineering, Inc., has submitted a supplemental Engineering Services Agreement in the amount of \$36,644.00 for updated contract plans contract documents.

NOW THEREFORE BE IT RESOLVED, by the County Board of Sangamon County at its Regular Reconvened Adjourned September Session, assembled this 13<sup>th</sup> day of February, A.D., 2013 that there is hereby appropriated from the County's Motor Fuel Tax Fund the sum of \$36,644.00 for additional preliminary engineering services to be performed by Quigg Engineering, Inc.

BE IT FURTHER RESOLVED, that the Supplemental Engineering Agreement between the County and Quigg Engineering, Inc. providing for additional preliminary engineering services required to complete the work as specified in the supplemental agreement, designated as County Section 06-00051-03-FP & 06-00064-06-WR, is hereby approved; and,

BE IT FURTHER RESOLVED, by the County Board of Sangamon County that the Chairman of the County Board is hereby authorized and directed to sign said Supplemental Engineering Agreement on behalf of Sangamon County.


