**WHEREAS**, the Public Health, Solid Waste and Zoning Committee (PHSWZ) is tasked with critical duties and responsibilities that affect the property and lives of every resident of Sangamon County; and

**WHEREAS**, throughout its existence the PHSWZ Committee has done an admirable job performing those critical duties and functions of the committee as outlined in the Sangamon County Code; and

**WHEREAS**, the workload and the complexity of the duties of the PHSWZ has grown with each year, putting a strain on the limited time available for the committee to convene and discuss those matters; and

**WHEREAS**, in order to provide additional time for discussion for committee members and additional input from the public on those issues before the PHSWZ Committee it has been proposed that the PHSWZ be separated into two committees; and

**WHEREAS**, members of the PHSWZ committee and members of the full Sangamon County Board have been consulted on the proposal of the PHSWZ being separated and reconstituted as two separate committees; and

**WHEREAS**, those members consulted agreed with the proposed separation and subsequent creation of two new committees, the Public Health Committee and the Zoning and Land Use Committee; and

**NOW, THEREFORE, BE IT RESOLVED** by the County Board of Sangamon County, in session this 8th day of December, 2020 that the Public Health, Solid Waste and Zoning Committee be separated and reconstituted as two new committees, the Public Health Committee and the Zoning and Land Use Committee.

**2.04.440 Public Health, Solid Waste And Zoning Committee; Powers And Duties Designated**

The Public health, solid waste and zoning committee shall:

- ~~1. Have jurisdiction over all matters pertaining to county planning, zoning, and subdivision, except in matters related to highways, roads and bridges;~~
- ~~2. Work with the Sangamon County regional planning commission and report such activities to the board at the June meeting;~~
- ~~3. Perform functions relating to subdivision regulations as prescribed in the Sangamon County subdivision ordinance, as amended;~~
1. Have oversight of expenditures and hiring approved by the board of health for the public health department;
- ~~2. Have oversight of expenditures and hiring for the zoning department;~~
3. Perform all other functions in the areas of **planning and zoning public health** as may be authorized by law.
4. Be responsible for developing a solid waste management plan for Sangamon County in accordance with the directions of the Illinois Public Act 85-1198;
5. Work with the Sangamon County department of public health in the oversight of the county solid waste plan and enforcement of solid waste laws, rules and regulations.

**2.04.441 Zoning and Land Use Committee; Powers And Duties Designated**

The Zoning and Land Use committee shall:

1. Have jurisdiction over all matters pertaining to county planning, zoning, and subdivision, except in matters related to highways, roads and bridges;
2. Work with the Sangamon County regional planning commission and report such activities to the board at the June meeting;
3. Perform functions relating to subdivision regulations as prescribed in the Sangamon County subdivision ordinance, as amended;
4. Have oversight of expenditures and hiring for the zoning department;
5. Perform all other functions in the areas of planning and zoning as may be authorized by law.
