

RESOLUTION 5-1

WHEREAS, the numerous bicycle and multi-use trails have been constructed within the boundaries of Sangamon County; and,

WHEREAS, the Springfield Park District, Village of Rochester, Village of Chatham, City of Springfield and the Sangamon County Highway Department, under the guidance of the Springfield-Sangamon County Regional Planning Commission have formed Multi-use Trails Jurisdiction Committee; and,

WHEREAS, the Multi-use Trails Jurisdiction Committee has been meeting since September 23, 2015 to address various needs of the trails constructed within Sangamon County; and,

WHEREAS, the Multi-use Trails Jurisdiction Committee has created the "Emergency Response Support Signage" and "Advertising, Sponsorship, Directional and Wayfinding Signage" Policies that will allow a uniform development of location, wayfinding and directional signage on all trails within Sangamon County; and,

WHEREAS, the Parties of the Multi-use Trails Jurisdiction Committee have the authority to participate in cooperative programs and share services with other governmental entities pursuant to Section 3 of the Intergovernmental Cooperation Act, 5 ILCS 220/3; and,

WHEREAS, the Parties wish to enter into an Intergovernmental Agreement to purchase and install signage as described in this Agreement with the Springfield Park District acting as the lead agency.

NOW THEREFORE BE IT RESOLVED, by the County Board of Sangamon County, at its **Regular Reconvened Adjourned June Session**, assembled this 8th day of August, A.D. 2014 approve said Intergovernmental Agreement to purchase and install signage, and;

BE IT FURTHER RESOLVED, by the County Board of Sangamon County that the Chairman of the County Board is hereby authorized and directed to sign said Intergovernmental Agreement on behalf of Sangamon County.
