**WHEREAS**, bids were opened in the office of the County Engineer on January 25, 2008 for the construction of a new bridge on Mansion Road in New Berlin Township; and,

**WHEREAS**, one (1) bid was received with the low bid being submitted by County Contractors in the amount of \$211,220.92; and,

**WHEREAS**, the low bid is below the approved Engineer's Estimate of Cost of \$254,308.00.

**WHEREAS**, the County proposes to use State Township Bridge Funds to pay for up to 80% of the construction cost with the remaining 20% to be split evenly between the County Bridge Fund and Island Grove Township funds; and,

**NOW THEREFORE BE IT RESOLVED**, by the County Board of Sangamon County at its **Regular Reconvened Adjourned September Session**, assembled this 13<sup>th</sup> day of February, A.D., 2008, that the low bid from County Contractors in the amount of \$211,220.92 for the construction of a new bridge on Mansion Road in New Berlin Township be accepted; and,







